

CRITERIA & REQUIREMENTS FOR MBBS ADMISSIONS IN SESSION 2025-26

Admissions at Suleman Roshan Medical College, Tando Adam, Sindh would be strictly on merit without consideration to gender, religion, race, creed, color or domicile. Students from anywhere in Pakistan and overseas may apply. There are no quotas, reserved seats or admissions against donations. Merit-based admissions are open to candidates from around the world.

Following is the criteria and requirements for admissions to the Medical (MBBS) program at Suleman Roshan Medical College (SRMC) for review and final approval by the Pakistan Medical and Dental Council (PM&DC) in exercise of the powers conferred under clause (f) of sub section(2) of section 9 and sub section (2) of section 47 of the Pakistan Medical and Dental Council Act 2022 (Act no. 4 of 2023), the Pakistan Medical and Dental Council is pleased to make the following regulations, namely:- Medical and Dental Undergraduate Education (Admission Curriculum and conduct) Policy and Regulation 2023

ELIGIBILITY REQUIREMENTS

- a) Obtained a Higher Secondary School Certificate qualification ("HSSC") or an equivalent 12th grade qualification recognized in Pakistan and **obtained a minimum of sixty percent (65%)** marks therein, or a higher percentage as may be notified by the Pakistan Medical & Dental Council; and
- b) Passed the subjects of biology and chemistry and either physics or mathematics in the examination of the Higher Secondary School Certificate or an equivalent 12th grade qualification recognized in Pakistan:
- c) He /She must have passed the MDCAT examination held by Pakistan Medical and Dental Council (PM&DC) or University (as the case may be or notified accordingly by the PM&DC). **The passing marks for MDCAT would be 55% or as defined/announced by PM&DC or the exam conducting authority.**

A. CALCULATION OF MERIT

The criteria and merit formulation as prescribed in the regulations for admissions as under:

MDCAT	50% weightage
F.Sc (Pre-Medical)/HSSC/Equivalent	40% weightage
SSC/Matriculation/Equivalent	10% weightage

- a. If two or more students have exactly the same merit up to five decimal points, the students in merit shall be listed by age with the student older in age being placed higher than the student lower in age.
- b. This aggregate wise merit shall be used by the college for the purpose of final admission offer, subject to certain requirements to be fulfilled including fee submission & documentation etc.

The information provided is subject to change due to certain government policies including but not limited to MDCAT and SAT-II entry test for overseas/foreign candidates, any quota announcements for under developed areas of Gilgit, Baluchistan & tribal areas of old FATA etc by Federal and/or provincial government.
